Please help a widow in pain and suffering to insure my husbands life long work has not been in vain. An organization we are a member of took over his assets and did not contact me regarding his hospitalization last year. They lied to me about when and where he died and then would not tell me the date he died or explain what is going on...I called every hospital and government organization to locate him in Colorado. It is a closed book policy so could find nothing. I contacted the organization numerous times to talk with the head of it ..to no avail.

The family in California that organization contacted lied to me and said he died in a car accident in Ca. I called every hospital in LA and still no luck. Why would they say California when he had just moved to Colorado? He gave many of his belongings to an individual in the organization in California who refused to tell me the truth about his hospitalization. I then went to the Probate court in Colorado by borrowing money from friends who were very kind to loan me just enough for an airline ticket, who I will pay back one day, and flew to where he had just bought a condo.

The spiritual organization we are a member of said they could not reach me (not true since I am a member and they have all my current info-email and every phone number with them) and instead they contacted individuals on my sisters side of the family who was the one who lied to me about where he

died. These individuals are so immature they will not return my phone calls- nor will the spiritual organization and my sisters family who are programmed by her.. After filing in Colorado Probate court to complain about this I was sent to the DA's office by the civil office to file a crime report only to be turned away by the DA saying "it is not a crime to lie or steal in a probate case that we will pursue, you must file a civil lawsuit".

In the meantime I cannot find out from the local organization where he is and what is going on with his business and assets nor will they return my calls. I told the DA's office that the civil court told me to come talk to him first so that is why I am here...He said "who sent you here???" Go back and file inside a civil lawsuit against these people. They were closed and it was Friday by the time the DA reserached where my husband might be only to find out he had been taken by ambulance on my birthday Dec. 17th somewhere in Colorado.

I had no money to stay anywhere when I arrived in Colorado and had to do this research by staying awake by walking all night to keep warm for 2 days and nights and took buses to get around to do the investigation. I ate 1 bowl of granola in 2 days and was fortunate the Marriott let me use their computer for the research. It took too long on the buses and I had a return ticket and had to get back to LA to cover my bills there...now I have to go back and finish this. I have to file documents and appear in court again in Colorado and dig up papers in other parts of the country to show the court...I should hire an attorney and need funds to do this as well as for the airfare to go back to court in Colorado and paying for rents and expenses for phone while I am away. I even would like to move there now to handle this so need funds for that. I was preparing to move there and had to put it on hold when I found out about this February 13/13/ I have to file the civil charges and pay for these legal fees .

My goal is to insure my husbands assets will be put to good projects that will spiritually assist people in a practical way within this organization or whatever

outcome comes of this and to get clarity in details so I may assist him here and now so that this spiritual organization will not conduct themselves ever again in this manner and instead be supportive to members in any family who have a death or some other crisis who may need financial assistance or to get on their feet etc...His business must go on and work to benefit others instead of this corruption and his assets must be used in the correct way and to continue the spiritual work in a practical application to create harmony and love rather than this abuse of power.

I will continue to work hard to ensure our business to benefit others goes smoothly and we will continue to be working together (him from an unseen dimension now) to benefit others as has been the entire purpose and proven efforts of both of our lives when we were married and formed a contract and agreed in 1969 to work together to create in our lifetime the Advanced University Project for Mankind, in California "Knowledge Unlimited" corp. which I now call the Advanced Community project for Humankind and will go on without further delay with all of your help with this mission.

If we go forward to create harmony and have clarity in our communications within our local family and organizations we will all create better conditions for the greater good of this precious Mother earth who gives us life to support the physical part and the Divine Father which gives us Life Spiritually which is the Precious Life Force which gives us the father-mother essence of this precious human life in Its wholeness. May we work together to promote Good works and Good will on Earth regardless of dogma and our variety of spiritual connections.
